IMPORTANT NOTE: TAXPAYERS MUST BRING TO THE APPOINTMENT:

- SPOUSE, IF MARRIED AND FILING JOINTLY
- SOCIAL SECURITY NUMBER AND PROOF OF IDENTITY (PICTURE OR OTHER DOCUMENTATION)
- ALL 2009 INCOME STATEMENTS RECEIVED FOR TAXPAYER AND DEPENDENTS:
 - SSA-1099 FORMS (SOCIAL SECURITY BENEFITS PAID)
 - ALL 1099 FORMS (1099-INT, 1099-DIV, 1099-R, 1099-B, 1099-MISC, ETC.)
 - W-2 FORMS FROM EACH EMPLOYER
 - UNEMPLOYMENT COMPENSATION FORMS
 - FORMS THAT INDICATE FEDERAL AND/OR STATE INCOME TAXES PAID DURING 2009
 - ORIGINAL COST OF ASSETS SOLD DURING 2009
 - COPY OF FEDERAL AND/OR STATE INCOME TAX RETURNS FILED LAST YEAR
- PERSONAL CHECK, IF AVAILABLE, WITH BANK CHECKING ACCOUNT & ROUTING NUMBER
